

Ensuring safer communities through effective collaborations

Gun violence continues to be a public health crisis throughout America, and a top priority for many Chicagoans who are pressing local governments to do more to increase public safety. As we've <u>reported in the past</u>, the City, County, and State are leveraging America Rescue Plan Act (ARPA) funds to invest in sustainable violence reduction. In 2023, it is estimated that approximately \$175M in public funding will go to violence prevention and intervention, a significant leap from the \$10M spent in 2017.

This increase in funding over a short period of time has created monumental shifts in the violence prevention and intervention ecosystem for both grantmakers, and those who are delivering services at the ground-level. To meet this challenge, Civic Consulting Alliance is supporting multiple, interconnected clients to ensure quick and effective scaling of these concerted violence reduction efforts.


